7. ML Card can be considered as a valid ID, if enrolled and registered in the M. Lhuillier KYC online system.
8. M. Lhuillier Financial Services, Inc. reserves the right to require another ID in certain transactions as proof of identity despite the presentation of the ML Card by the customer.
